An OES number was received and we began getting support from our teams. Goodman was notified of the accident in Morongo Valley involving one of our teams about 05:45, Saturday July 17. Goodman learned of the death of Scott Johnston shortly afterward and began getting the necessary support then letting the teams know what happened. The accident occurred about 0515.

#### **Doctor Jim Evans**

1. His team's unit was about 2 to 5 minutes behind the accident. Doc described the scene with the injured and his medical efforts taken at the scene. There were many emergency personnel arriving from various teams as the seconds went on.

Team members talked about the events and gave their inputs of the events.

**Members of the department** discussed additional information both medical and factual; however, these minutes were taken by each team and will not be recorded for our records due to the nature of the discussion.

Emergency notification forms need to be up to date. It was suggested that copies be in all unit vehicles! Disaster service workers forms need to be complete! These are normally completed during the initial application process.

Minutes were terminated during the discussion due to the ongoing investigation and out of respect for all those involved.

## VII. IESAR FUNDRAISING
